- 5) New issue related to the status of C37.100.1 was discussed with the following conclusions:

Paul Barnhart made a motion to follow option C (remove references to C37.100.1 completely) with Mike Orosz seconding. The motion was carried with 1 objection and 1 abstention.

Chand Tailor made a motion for a draft to be circulated for the WG to review with a 15-day response time before re-balloting with T. Mulcahy seconding. The motion was carried with no objections or abstentions.

6) Document Review

Of the 48 total comments received, 3 were technical, 4 were general, and 41 were editorial. There was a 91% response rate of the 116 balloters with >90% approval.

Dispositions from the resolution committee for Draft C37.20.9-D5.2 that was distributed before the meeting were accepted with only one topic being discussed and rejected.

Additionally, the topic of what to do about incorporating the work coming out of the control wiring task force is performing was discussed and decided that we would not.
